- The NE CSCS is holding a special afternoon session on the impacts of sugar maple and maple sugaring at the <u>Forest Ecosystem</u> Monitoring Cooperative's annual meeting on December 15 at the University of Vermont.
- The new Northeast Refugia Research Coalition website is available. The Coalition is moving forward on comparing maps of spruce-fir refugia across the Northeast, as well as developing a plan for managing cold water stream refugia for brook trout, etc., with the state of Massachusetts, Keith Nislow (NRS), Ben Letcher (USGS), and others. Station and Regional Updates

Leslie Brandt, Climate Change Specialist (Northern Institute of Applied Climate Science - NIACS), Eastern Region

- The Climate Change Resource Center (CCRC) has a new topic page on the Effects of Drought on Forests and Rangelands.
- NIACS will be offering two 7-session online adaptation training opportunities this fall and winter. An urban forestry adaptation online training will be held beginning November 7 (registration is closed). Another training will be held beginning January 15 that focuses on forests in New England and New York. Registration is currently open for that course. - NIACS is also offering a 3-day, in person training in Minneapolis February 27-March 1. This training is geared for Forest Service climate change coordinators and resource managers in the East. Contact Leslie (lbrandt@fs.fed.us) to register.
- NIACS will be working with several national forests on adaptation projects in November. Leslie Brandt and Kristen Schmitt will be visiting the Shawnee National Forest to film a project supported by the Wildlife Conservation Society Adaptation Fund and meeting with Hoosier National Forest staff on using the adaptation workbook with a new project there. Stephen Handler and Kristen Schmitt will be meeting with the Ottawa National Forest to go through the adaptation workbook.

Emrys Treasure, Regional Inventory, Monitoring, and Assessment Coordinator, Southern Region

- In addition to work continuing on the Nantahala-Pisgah National Forests, the National Forests and Grasslands in Texas are working on their forest plan assessment. As this assessment continues, the Southern Region is looking for best available science sources on a wide range of climate-related topics, including to build meaningful partnerships and collaborations.
- The El Yunque National Forest in Puerto Rico had nearly completed their plan revision when they were impacted by Hurricanes Irma and Maria. Currently, as it should be, the focus is on the humanitarian response. All Forest Service employees have been accounted for. However, there is a long road ahead to recovery, including assessing the impacts on El Yunque and implications for their revised forest plan.
- There is lots of work and discussion related to restoration in the Southern Region, including longleaf and shortleaf restoration that is clearly aligned with increasing ecosystem resilience to many of the effects expected with climate variability and change.
- Sarah Wiener from the Southern Research Station and the USDA Southeast Climate Hub will be helping to design a "monitoring census" that will help to better define monitoring activities that may be important in informing understanding of climate variability and change. The first interview and survey phase of that project is nearly complete; the focus will be on analysis and interpretation of those data throughout the fall and winter.
