The first seminar (Feb 8 @330) will focus on "Improving climate-adaptation planning for coastal communities: local planning informed by regional hazard exposure analysis". Nate Wood with the USGS and Taj Schottland from the National Wildlife Federation.
- Several of the NE CSC staff are authors for chapters in the Fourth National Climate Assessment.
- NE CSC Fellow <u>Nigel Golden</u> will be presenting at the <u>Midwest Fish and Wildlife Conference</u> "Private Landscapes, Public Responsibilities" in Omaha, NE, on research and community involvement for urban monarch conservation "Assessment of Monarch Butterfly Habitat and Productivity in Urban Spaces: Methods and Approaches"; there will also be a poster by Toni Lyn Morelli on the "The Northeast Climate Science Center: Improving the way climate science informs resource management".
- Great publications out lately:
- Northeast U.S. Temperatures Are Decades Ahead of Global Average: Temperatures across the northeastern U.S. will increase much faster than the global average, according to a new study from researchers working with the Northeast CSC. Their analysis, based on climate model simulations, indicates that the Northeast will warm 2-degrees Celsius (the target in the recent Paris Agreement) about 20 years earlier than the world as a whole. - New England's 1816 "Mackerel Year," Volcanoes and Climate Change Today: In 1815, the eruption of Indonesia's Mt. Tambora resulted in the unlikely takeoff of New England's mackerel fishing industry. In the latest issue of Science Advances, researchers working with the Northeast CSC recount their investigation into the effects of Tambora's volcanic winter on coastal fisheries and explore the lessons that can be drawn from a past climate catastrophe.
